CONFIRMATION OF STUDY PLACE

The following applicants till the number 7 (included) are admitted and must confirm the study place according to the following deadlines:

- **applicants with grant:** starting from August, 7th 2017 until August, 21st 2017;
- **applicants without grant:** starting from August, 23rd 2017 until September, 5th 2017.

They have to:

2. Upload the payment receipt as digital file (.pdf o .jpg) in the application portal:
<https://aws.unibz.it/exup>, (under "Confirmation of the Study Place/Enrolment")

Please note that payment will only be accepted once the receipt has been uploaded in the portal - it is not enough just to make the payment, otherwise you will lose your study place!

If you do not respect this deadline, you will automatically lose your study place.

If by paying the instalment you have confirmed the study place, but you do not enrol, there will be no refund of the tuition fees unless you are a non-EU applicant resident abroad and you do not receive the necessary documents from the Italian authorities in your country.

If you have been admitted to more than one PhD courses, you can only confirm a study place in one of them. With this confirmation you refrain from the admission to the other PhD courses and lose the right to move up in the other ranking lists.

If you do not have the required academic qualification, you will be given a conditional offer for a study place and you must submit your qualification upon enrolment. If you achieve your qualification after the enrolment deadline, you cannot enrol and you will lose your study place.

ENROLMENT PROCEDURE

Starting from August, 23rd 2017 until November, 3th 2017, 12:00 midday (GTM+1:00) applicants who have confirmed the study place must **enrol online** in the application portal <https://aws.unibz.it/exup>

If you do not respect the enrolment deadline, you will automatically lose your study place.

If you gained your qualification abroad you must upload the following documents (if not uploaded upon application):

- diploma of your qualification
- official translation of your diploma into Italian (translation is not necessary if the certificates have been issued in a German or English-speaking area)
- declaration of equivalent value of your qualification; EU citizens and citizens given parity of treatment can, as an alternative, upload the Diploma supplement, in the case they have achieved their university title in a Member State of the European Union (or in Switzerland, Liechtenstein, Norway or Iceland). The Diploma supplement must state:
 - that the student has achieved at least 300 credit points (ECTS) and
 - that the study title gives access to a PhD Programme.

If the university degree was obtained abroad and recognized in Italy, please upload a copy of the recognition decree.

In case of doubt, unibz reserves the right to request the declaration of equivalent value or further documents.

At the beginning of the academic year, you have to submit the originals of the above-mentioned documents to the Student Secretariat.


Please note: If you have been admitted in the ranklist, but you do not possess a valid entrance qualification, you could be excluded with Rector's decree even after enrolment.

If you are a non-EU citizen resident abroad:

According to Italian law, within 8 working days of your arrival in Italy, you must have applied for the **permit to stay**: as soon as you arrive you should go to the Advisory Service and you will be given all the information so that you can start this procedure.


Once you will obtain your permit of stay for Italy (permesso di soggiorno), you have to deliver it to the Student Secretariat personally or via e-mail.


